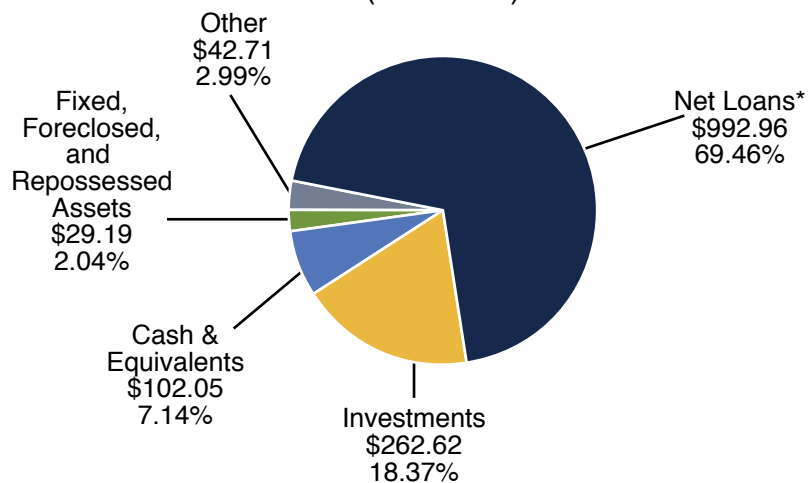

Asset Distribution (in Billions)

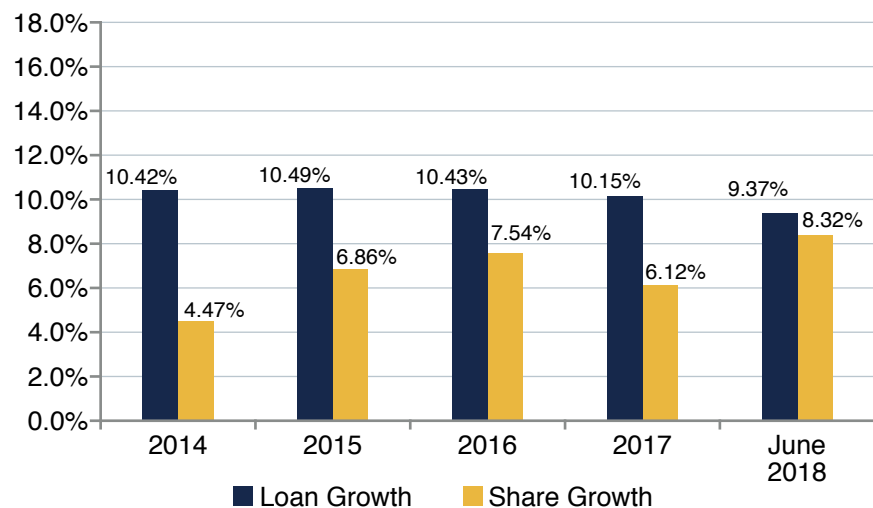

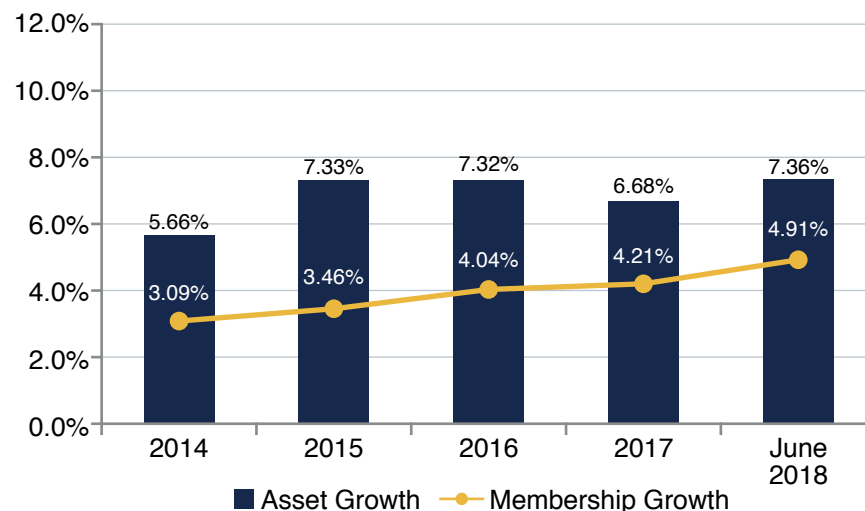

Loan Growth vs. Share Growth



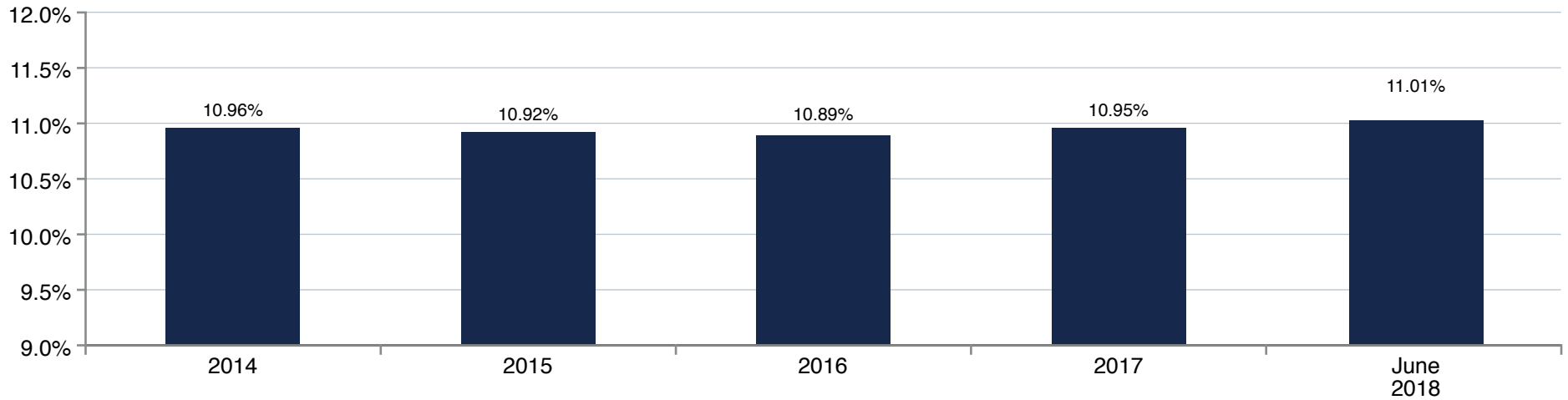
Asset Growth vs. Membership Growth

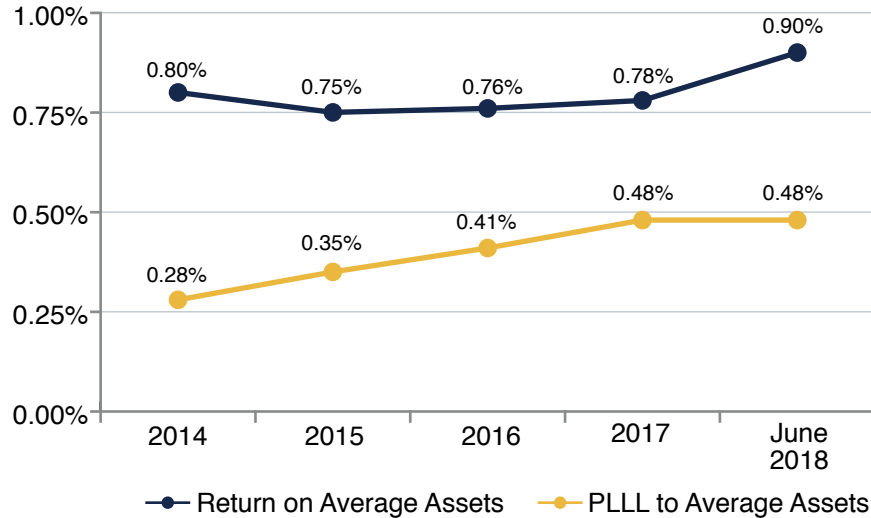

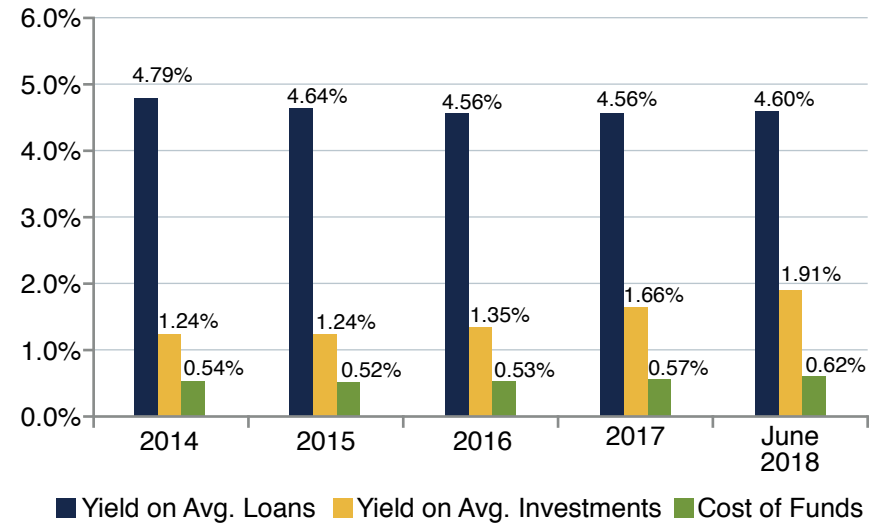

Yields vs. Cost of Funds

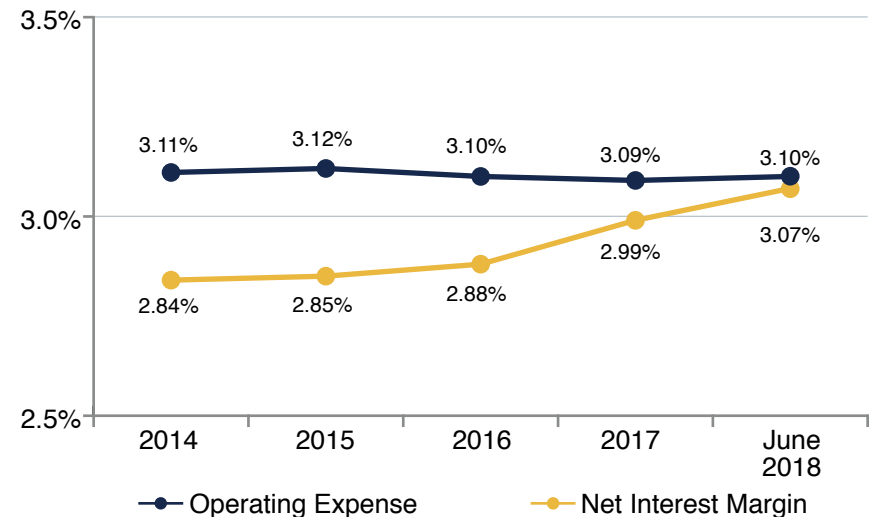

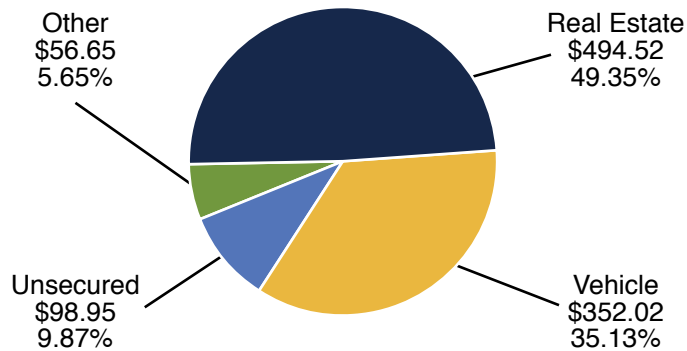
Operating Expenses vs. Net Interest Margin





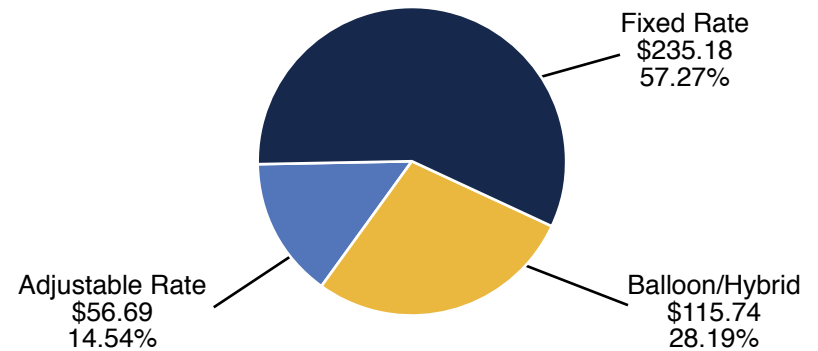

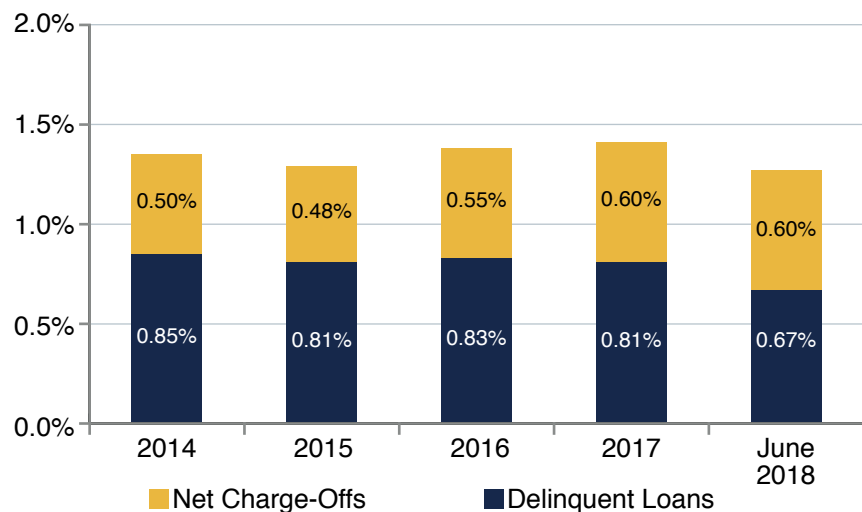

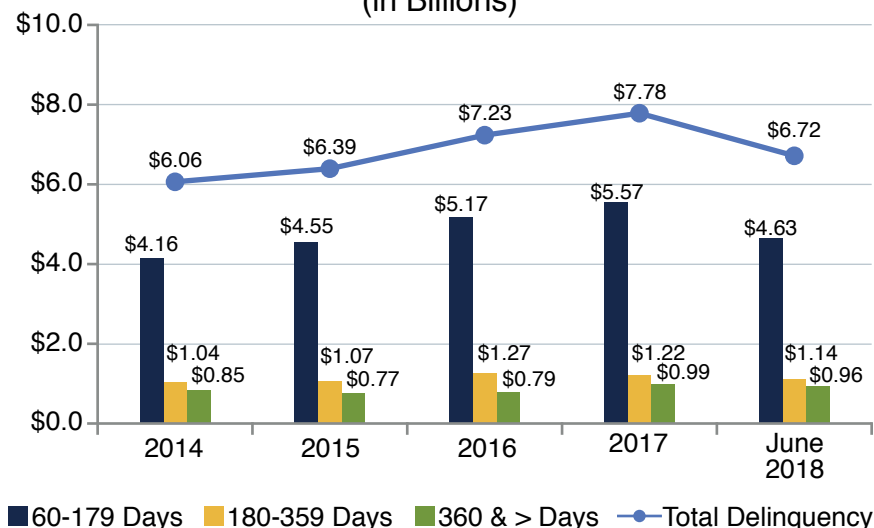

Delinquency (in Billions)

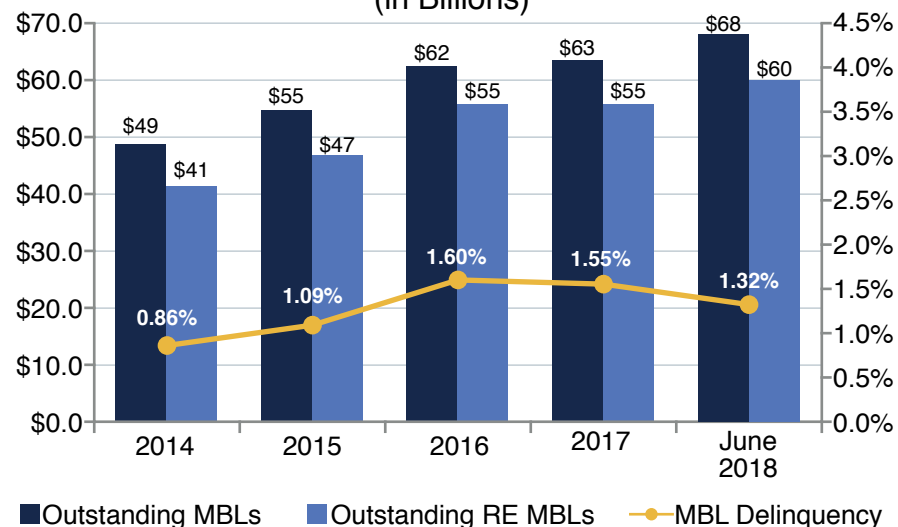

Commercial/Member Business Loans & Delinquency (in Billions)

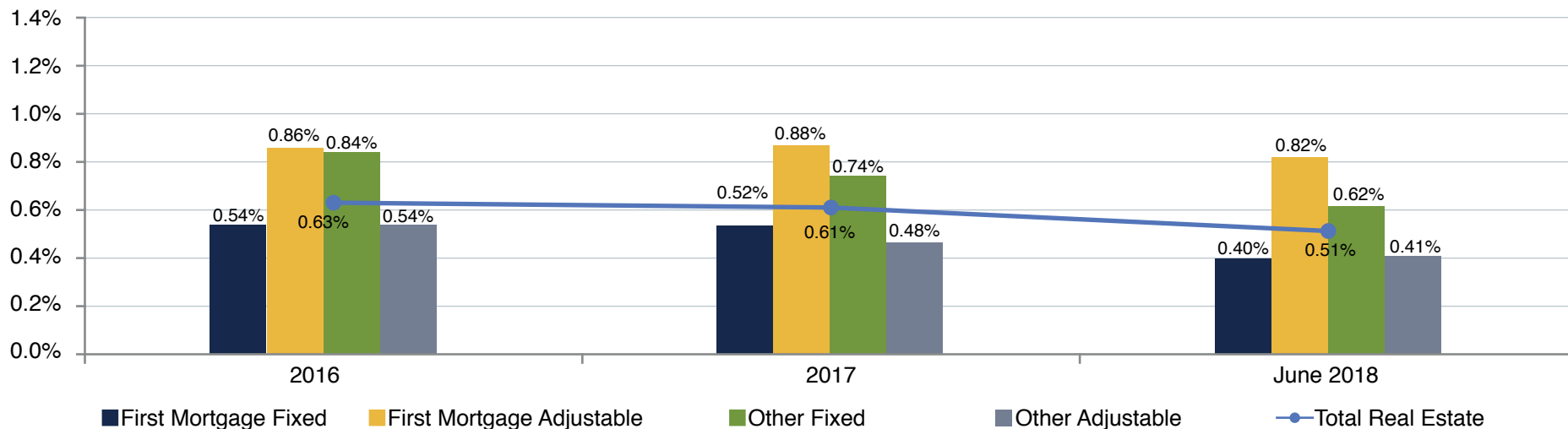

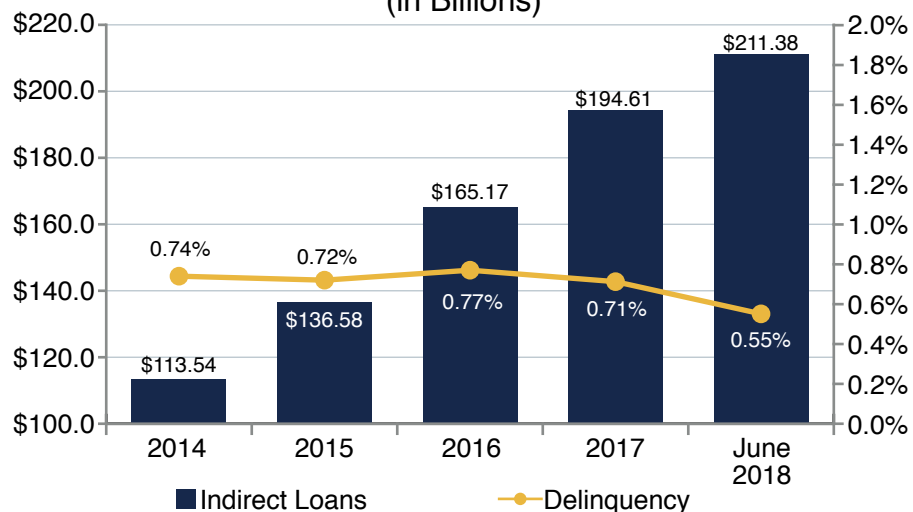

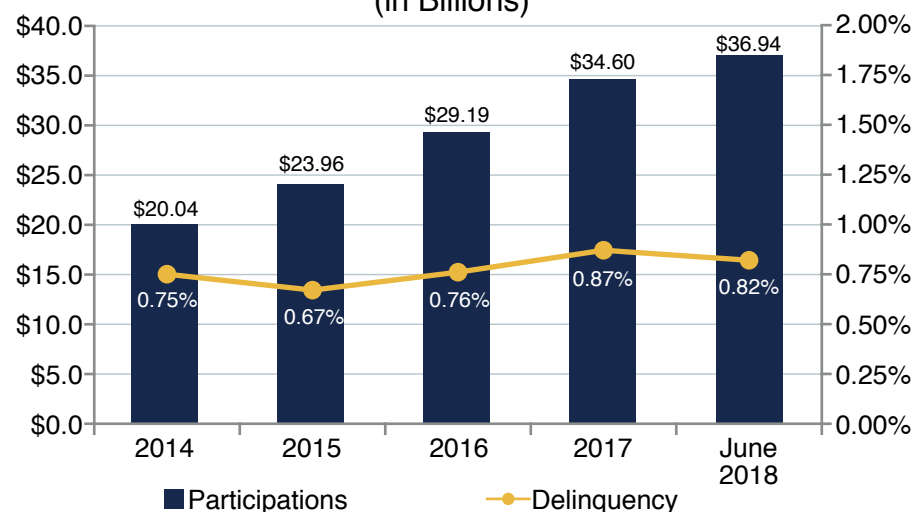
Real Estate Delinquency



Indirect Loans & Delinquency (in Billions)



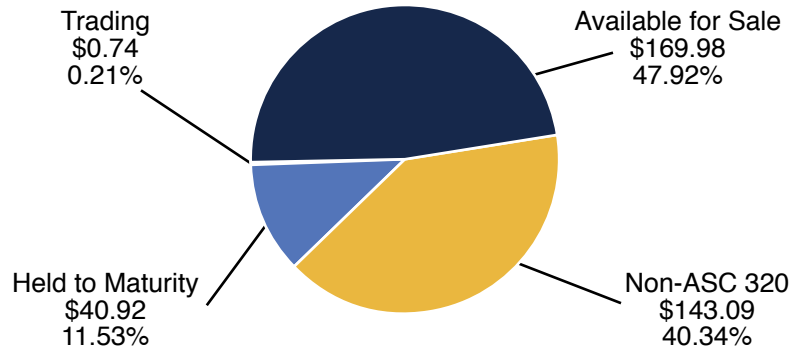
Participation Loans & Delinquency (in Billions)





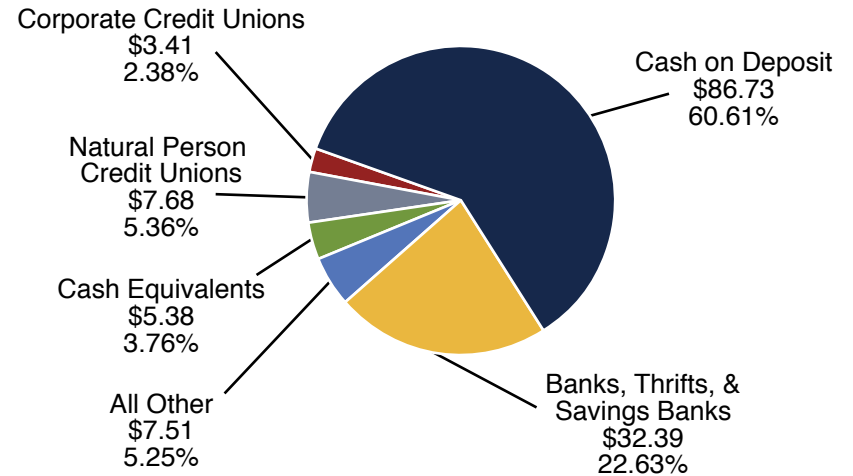

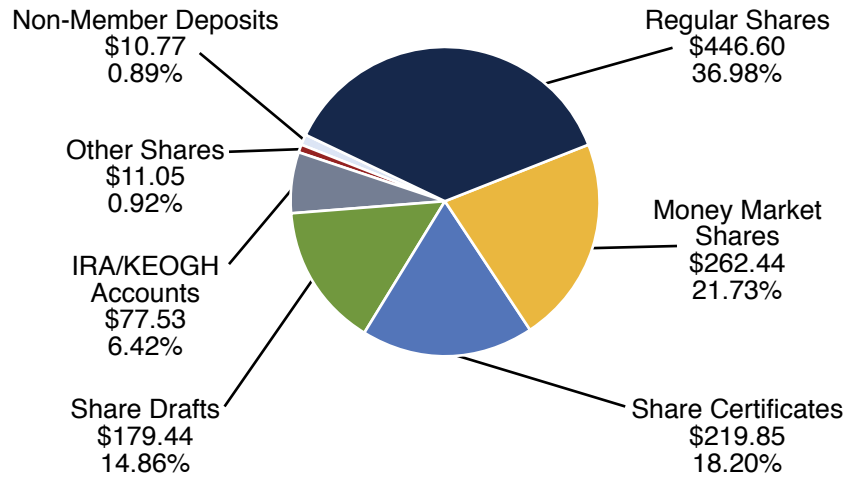

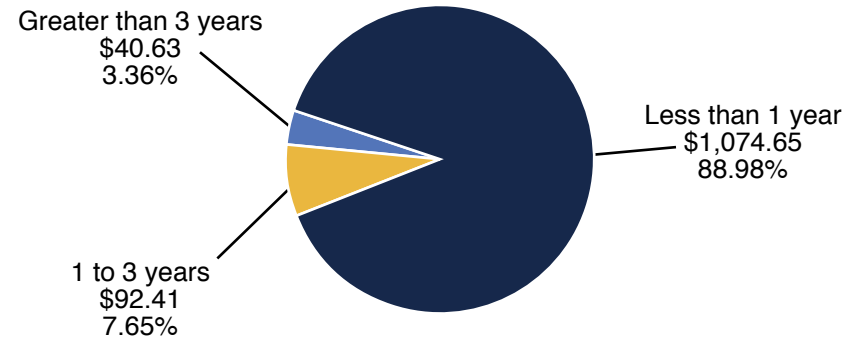
Share Trends

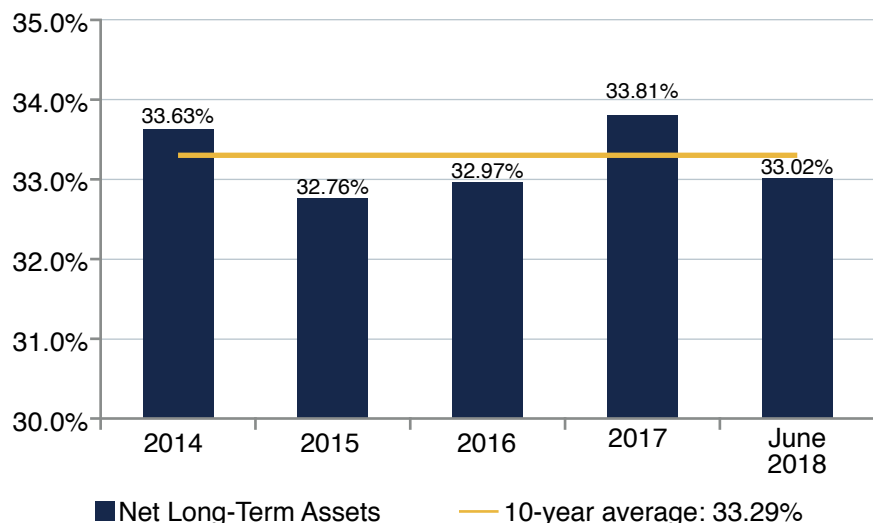

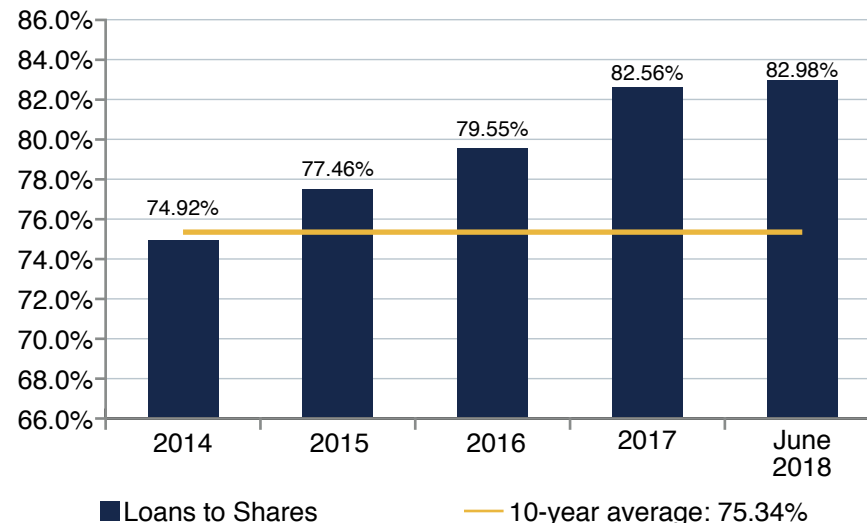

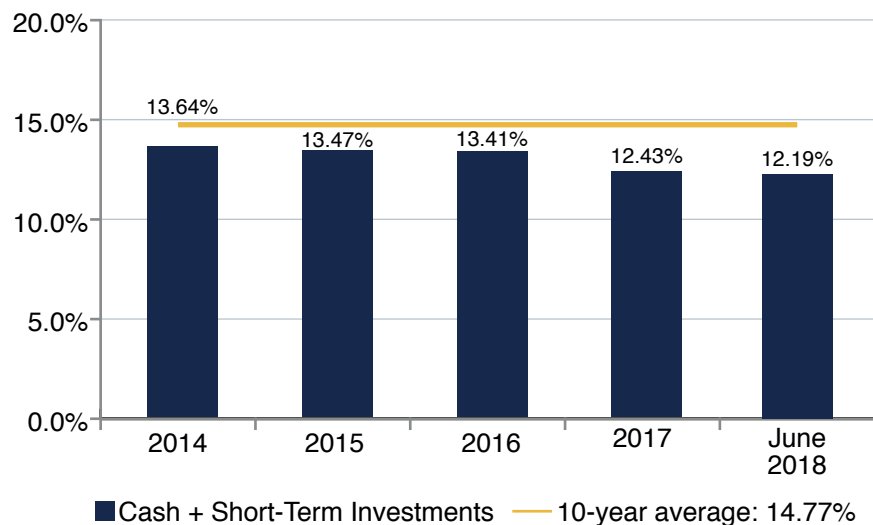
Net Long-Term Assets / Total Assets



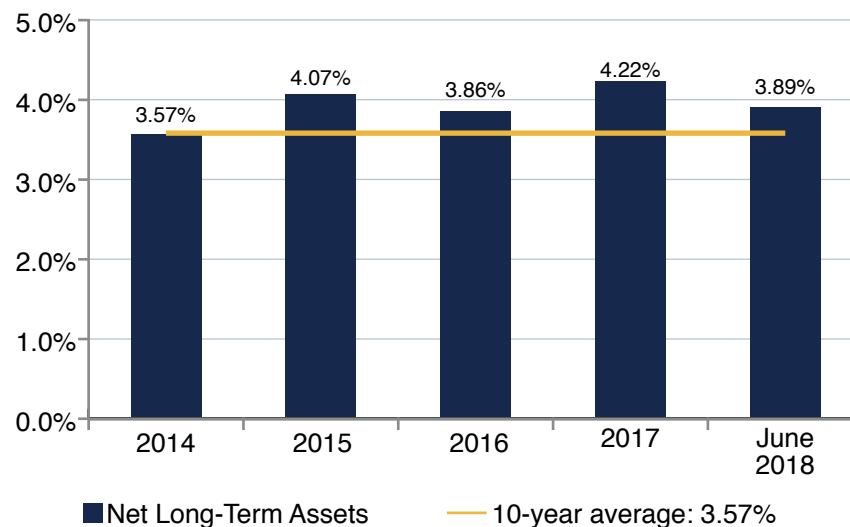
Total Loans / Total Shares
