NOTICE OF PROHIBITION

WHEREAS on or about November 15, 2016, Martina M. Papa ("Papa") was sentenced on the charge of Theft by Unlawful Taking-Movable Property, 18 Pa. Cons. Stat. § 3921(A), a charge to which she previously pleaded guilty, in the State of Pennsylvania's Court of Common Pleas of Westmoreland County, in connection with her employment at Teamsters Local 30 Federal Credit Union;

WHEREAS a violation of 18 Pa. Cons. Stat. § 3921(A) is a criminal offense involving dishonesty and breach of trust;

NOW, THEREFORE, YOU ARE HEREBY NOTIFIED THAT:

1. Pursuant to 12 U.S. C. § 1785(d)(1)(A) and 12 U.S.C. § 1829(a)(1)(A), Papa is prohibited from becoming an "institution affiliated party" of any insured depository institution, as defined in 12 U.S.C. § 1786(r); otherwise participating, directly or indirectly, in the conduct of the affairs of any insured depository institution; and owning or controlling, directly or indirectly, any insured depository institution;

- 2. Pursuant to 12 U.S. C. § 1785(d)(1)(B) and 12 U.S.C. § 1829(a)(1)(B), no insured depository institution may permit Papa to engage in any conduct or continue in any relationship prohibited in paragraph 1 above;
- 3. Pursuant to 12 U.S.C. § 1785(d)(3) and 12 U.S.C. § 1829(b), whoever knowingly violates paragraph 1 or 2 above is subject to a fine of not more than \$1 million for each day such prohibition is violated, or imprisonment for not more than five (5) years, or both;
- 4. The "Order of Court/Sentence" document, Case No. CP-65-CR-0003893-2015, is made a part hereof and is incorporated herein by reference; and
