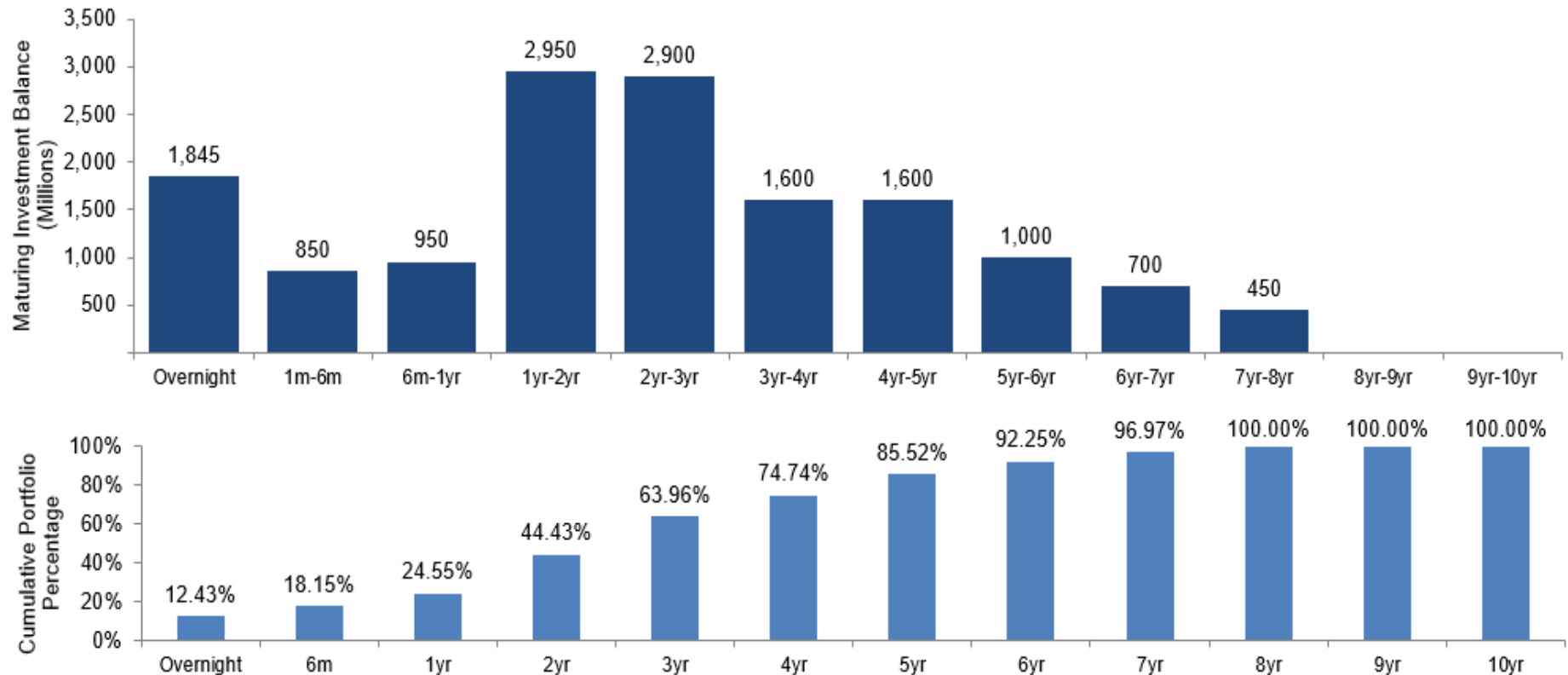

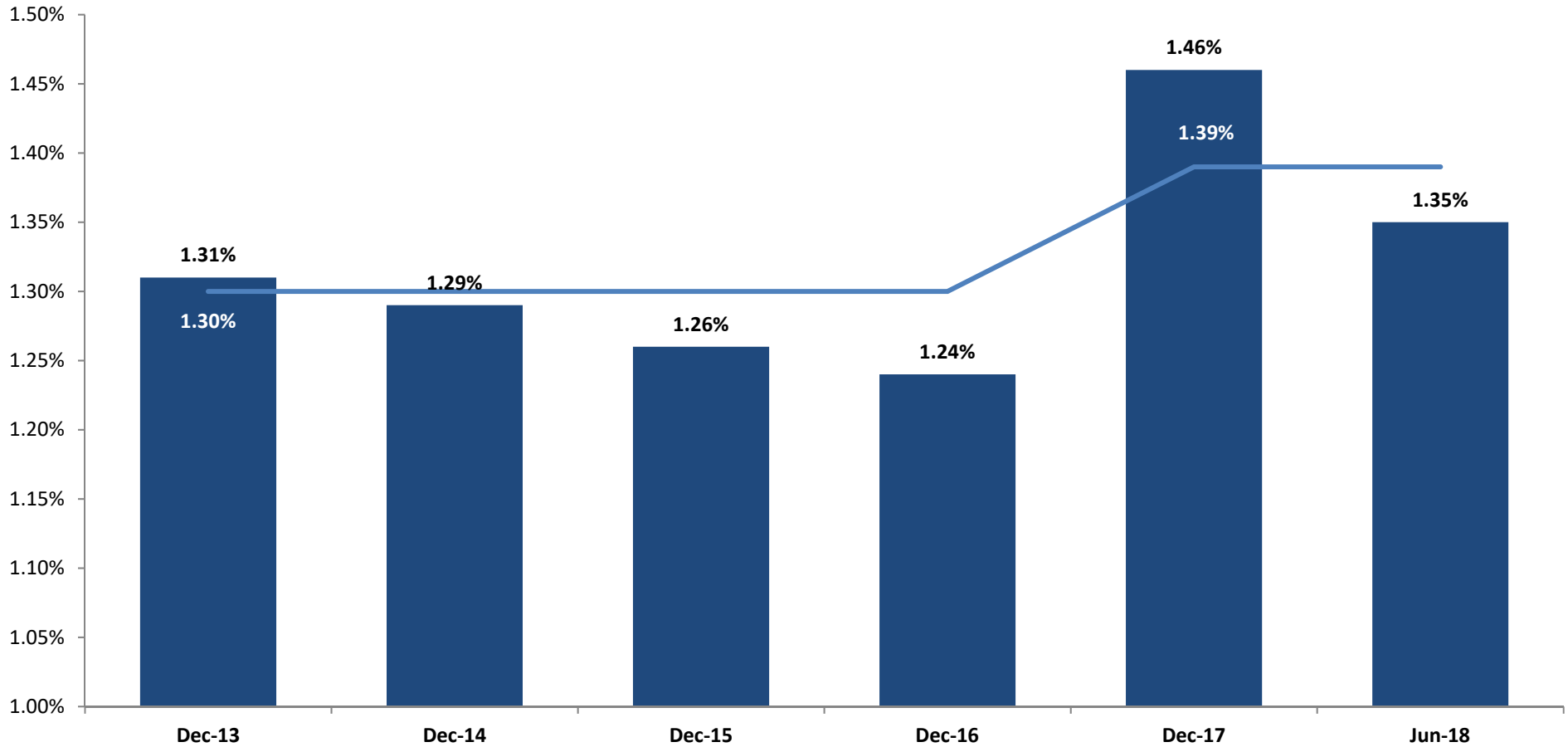

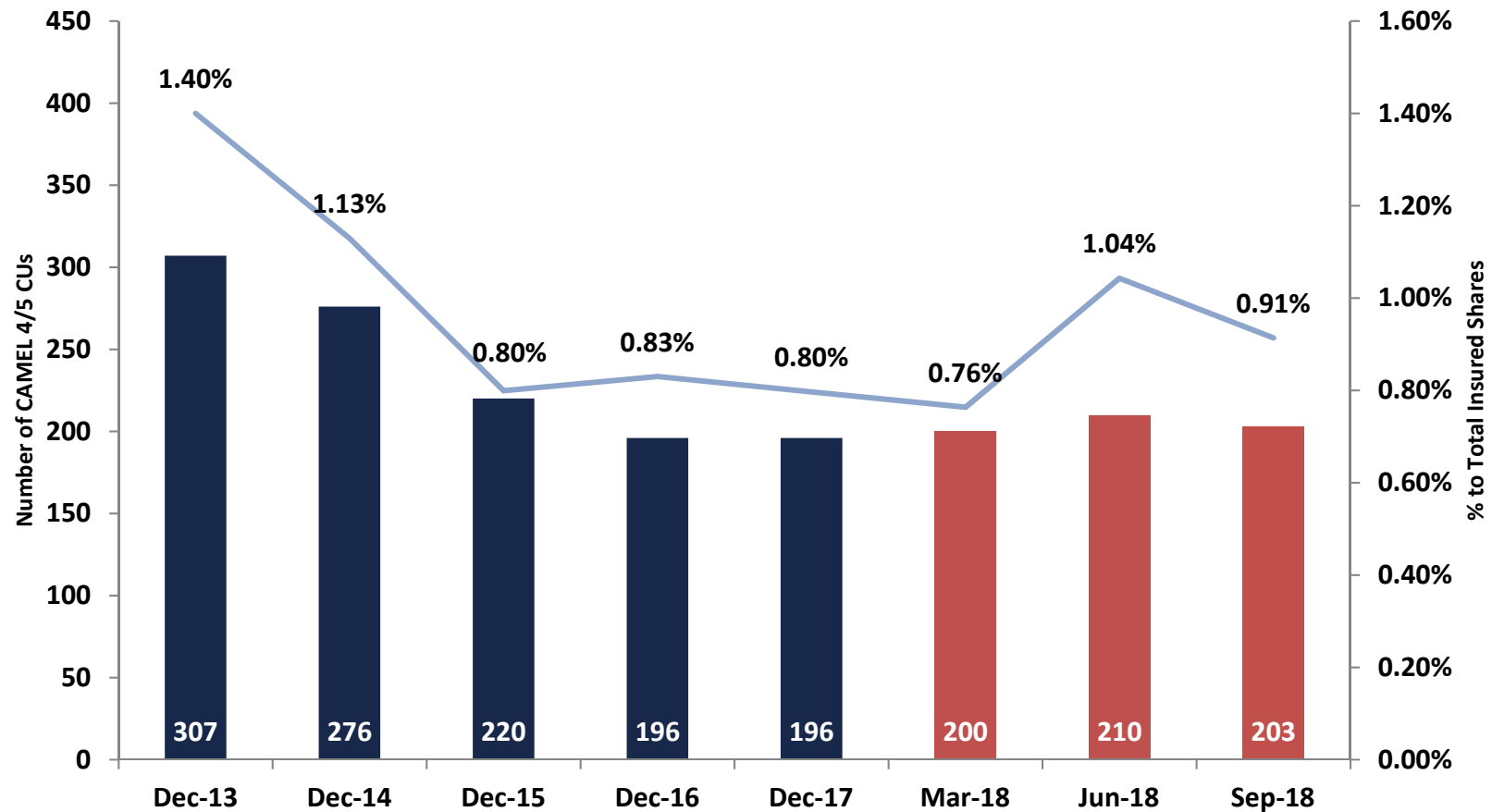
NCUSIF Equity Ratio

CAMEL Code 4/5 CUs with Percent to Total Insured Shares

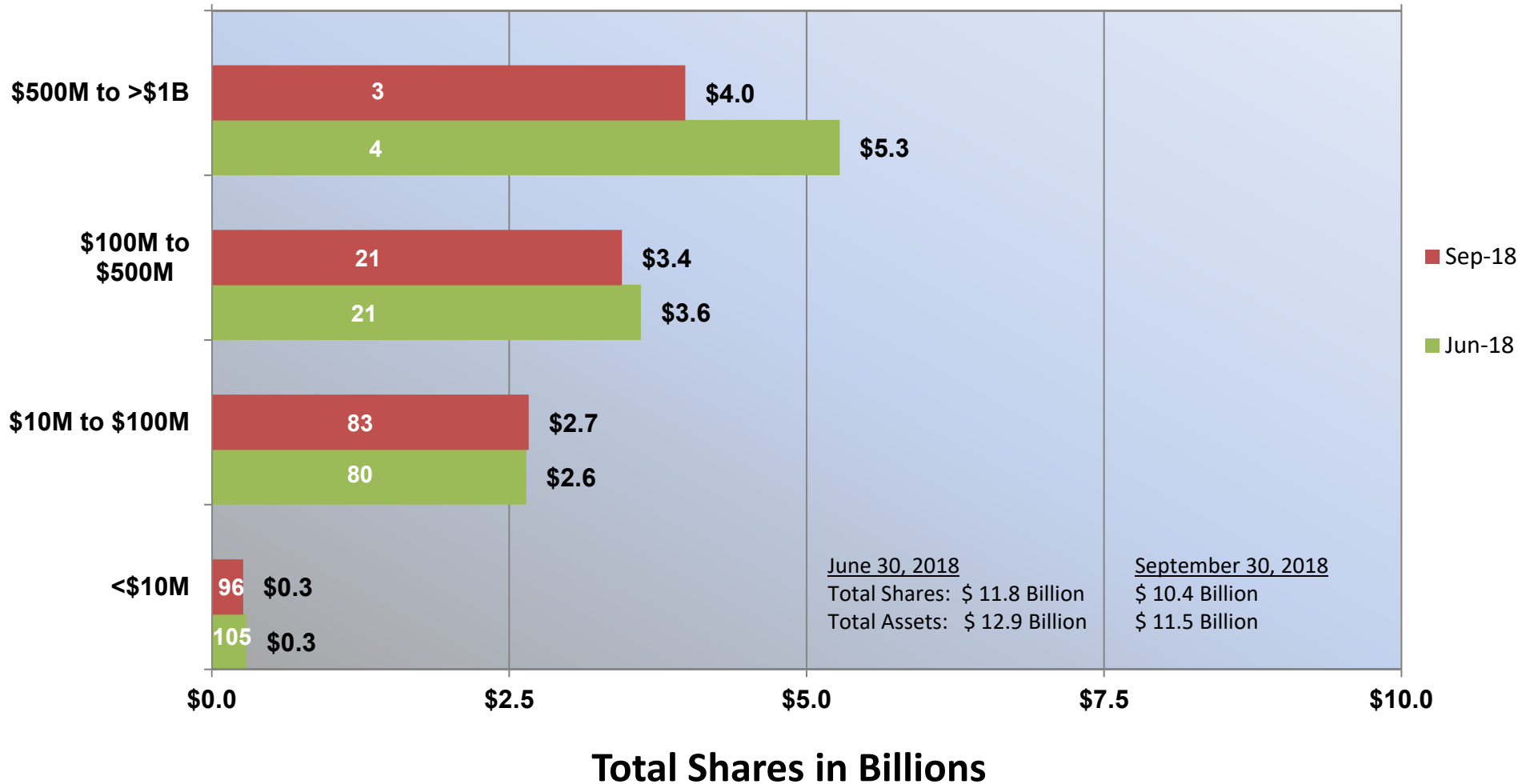

CAMEL Code 4/5 Comparison

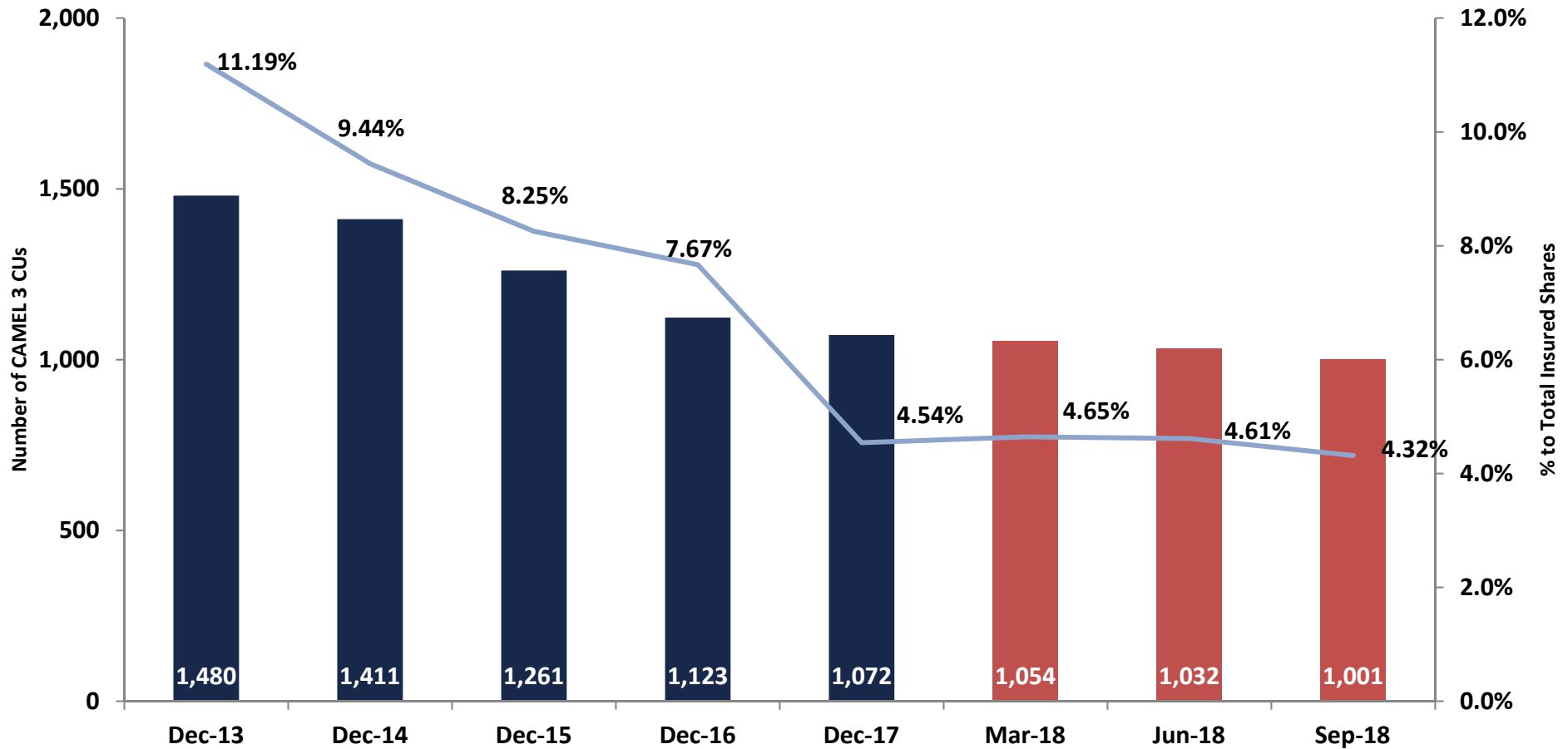
Credit Union Size

June 30, 2018 to September 30, 2018



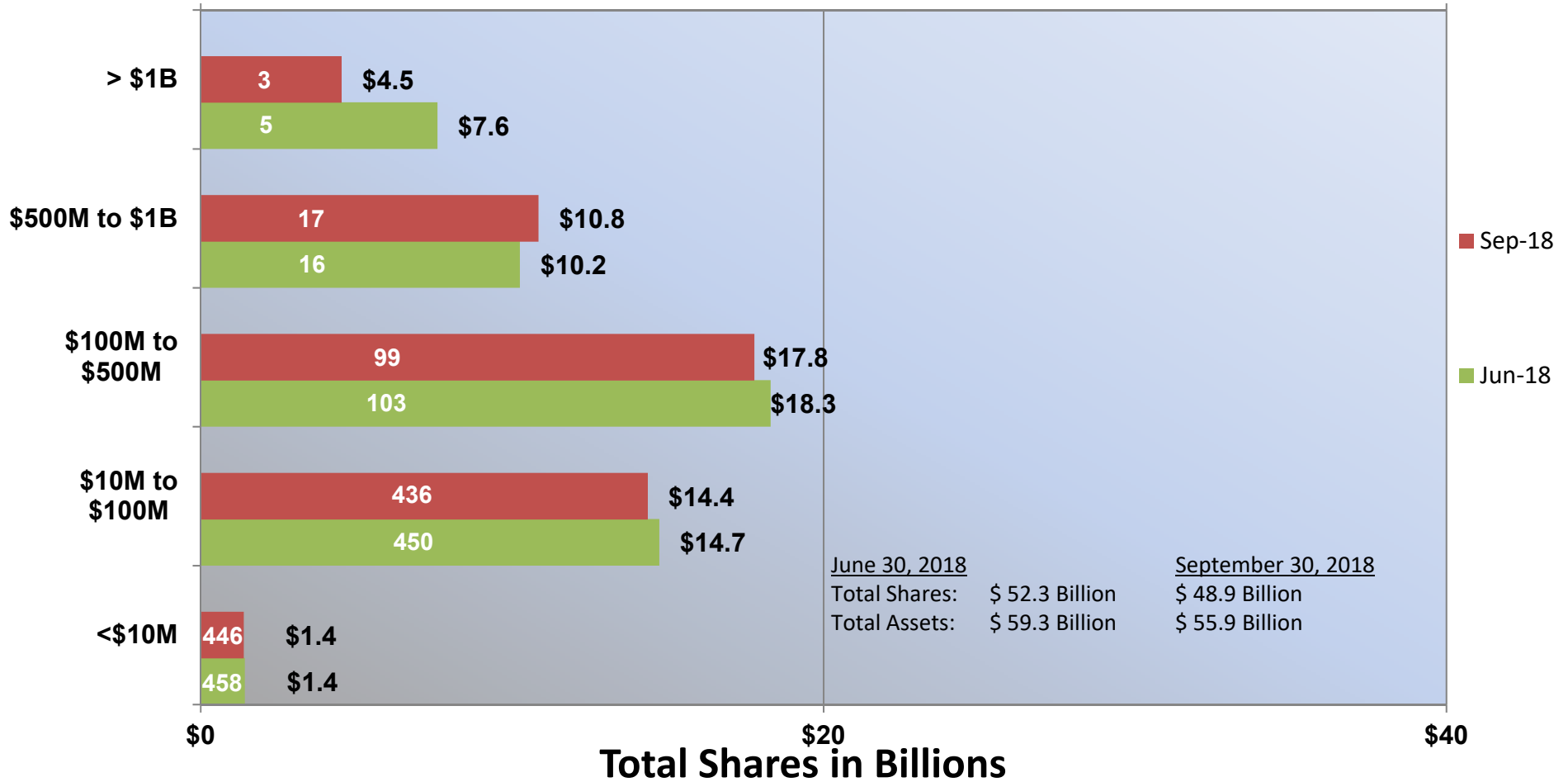
CAMEL Code 3 CUs with Percent to Total Insured Shares

CY 2013 – CY 2018



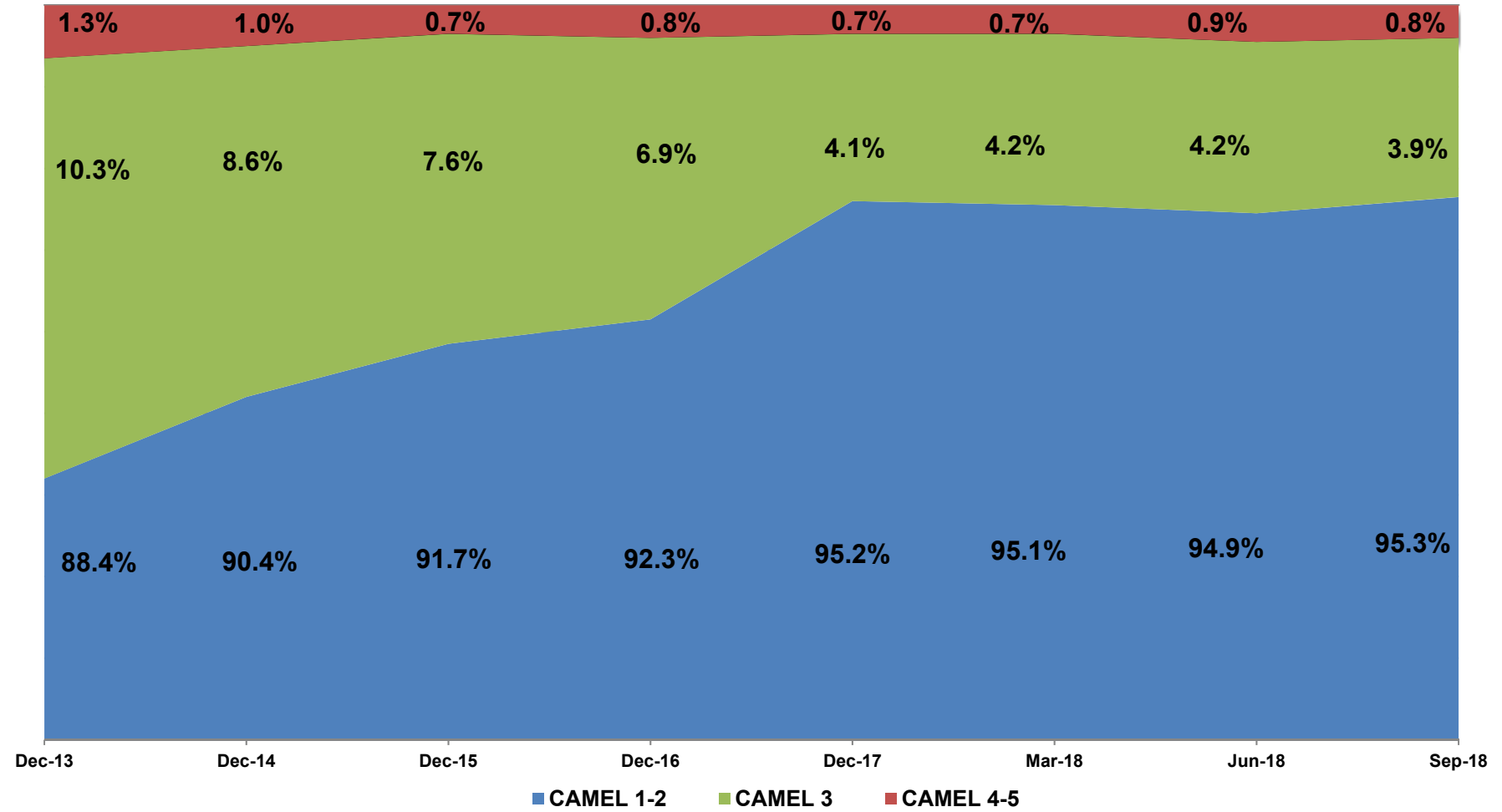
Percent of CAMEL Code 3 Shares to Total Insured Shares

Credit Union Size By Total Assets June 30, 2018 to September 30, 2018



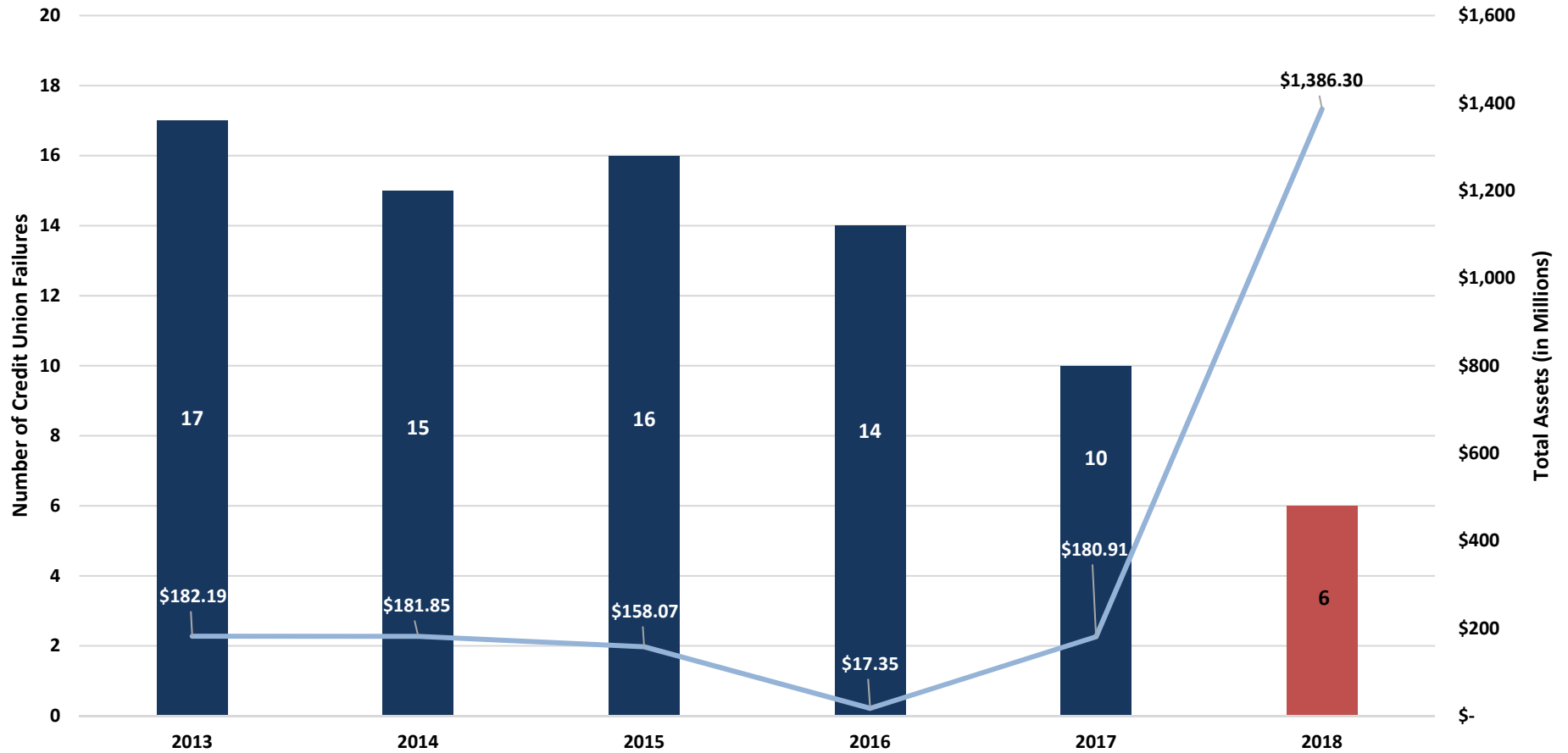
Distribution of Assets in CAMEL Codes

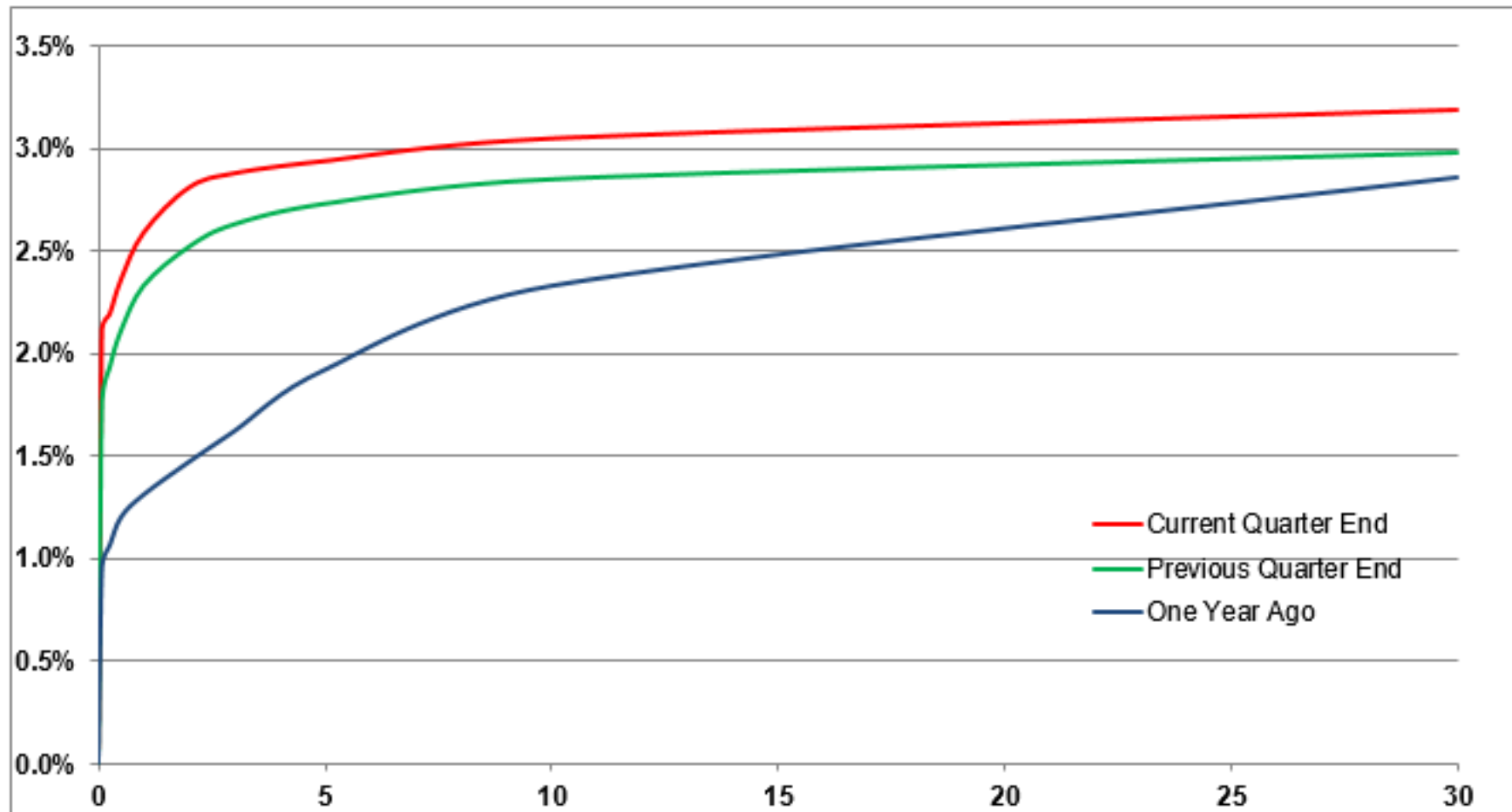
