## NOTICE OF PROHIBITION

WHEREAS on or about February 16, 2016, Schrelle L. Malone ("Malone") was sentenced on the charges of Grand Theft, Cal. Pen. Code § 487(a), Identity Theft, Cal. Pen. Code § 530.5(a), and Second Degree Burglary, Cal. Pen. Code § 459, charges to which she had previously pleaded guilty, in connection with her employment at Pacific Marine Credit Union, in the Superior Court of California in the County of San Diego;

WHEREAS violations of Cal. Pen. Code §§ 487(a), 530.5(a) and 459 are criminal offenses involving dishonesty and breach of trust;

NOW, THEREFORE, YOU ARE HEREBY NOTIFIED THAT:

1. Pursuant to 12 U.S. C. § 1785(d)(1)(A) and 12 U.S.C. § 1829(a)(1)(A), Malone is prohibited from becoming an "institution affiliated party" of any insured depository institution, as defined in 12 U.S.C, § 1786(r); otherwise participating, directly or indirectly, in the conduct of the affairs of any insured depository institution; and owning or controlling, directly or indirectly, any insured depository institution;

- 2. Pursuant to 12 U.S. C. § 1785(d)(1)(B) and 12 U.S.C. § 1829(a)(1)(B), no insured depository institution may permit Malone to engage in any conduct or continue in any relationship prohibited in paragraph 1 above;
- 3. Pursuant to 12 U.S.C. § 1785(d)(3) and 12 U.S.C. § 1829(b), whoever knowingly violates paragraph 1 or 2 above is subject to a fine of not more than \$1 million for each day such prohibition is violated, or imprisonment for not more than five (5) years, or both; and
- 4. The "Felony Minutes Pronouncement of Judgment" document, Case No. SCN324604, is made a part hereof and is incorporated herein by reference.
