NOTICE OF PROHIBITION

WHEREAS on or about January 5, 2016, Mary Brown ("Brown") was sentenced on the charge of Larceny over \$250, Mass. Gen. Laws ch. 266, § 30(1), a charge to which she pleaded guilty, in the Dudley District Court, of the Trial Court of Massachusetts, District Court Department, in Dudley, Massachusetts, in connection with her employment at Southbridge Credit Union:

WHEREAS a violation of Mass. Gen. Laws ch. 266, § 30(1) is a criminal offense involving dishonesty and breach of trust;

NOW, THEREFORE, YOU ARE HEREBY NOTIFIED THAT:

1. Pursuant to 12 U.S. C. § 1785(d)(1)(A) and 12 U.S.C. § 1829(a)(1)(A), Brown is prohibited from becoming an "institution affiliated party" of any insured depository institution, as defined in 12 U.S.C. § 1786(r); otherwise participating, directly or indirectly, in the conduct of the affairs of any insured depository institution; and owning or controlling, directly or indirectly, any insured depository institution;

- 2. Pursuant to 12 U.S. C. § 1785(d)(1)(B) and 12 U.S.C. § 1829(a)(1)(B), no insured depository institution may permit Brown to engage in any conduct or continue in any relationship prohibited in paragraph 1 above;
- 3. Pursuant to 12 U.S.C. § 1785(d)(3) and 12 U.S.C. § 1829(b), whoever knowingly violates paragraph 1 or 2 above is subject to a fine of not more than \$1 million for each day such prohibition is violated, or imprisonment for not more than five (5) years, or both;
- 4. The "Criminal Docket" document, Docket No. 1564CR003474, is made a part hereof and is incorporated herein by reference; and
